CLEARLY WRITTEN STANDARDS & POLICIES

Document these policies in writing and leverage the backbone of your compliance efforts.



DEDICATED COMPLIANCE OVERSIGHT

Assign a responsible individual or team with the authority and independence to lead compliance.



TIMELY RESPONSE & PREVENTION

Address issues swiftly and add issues to your ongoing monitoring activities for future prevention.



SANCTION ENFORCEMENT & ACCOUNTABILITY

Recognize adherence to policies, establish appropriate incentives & corrective discplinary actions.



ONGOING EDUCATION & TRAINING

Develop engaging training sessions and maintain open communication channels.



ENCOURAGE REPORTING & INVESTIGATION

Promote a culture where employees feel comfortable raising issues, with steps in place to identify areas of improvement.



CONSISTENT MONITORING & AUDITING

Regularly use internal checks to assess program success and identify any concerns early.
